# 587. Confirmation of Minutes:

The Minutes of the meeting held on 20 April 2022 were **RESOLVED** as a correct record of the proceedings thereat. Cllrs Munro and Richardson abstained due to not attending at the meeting.

#### 588. Clerk's Report:

 A follow up Public Meeting for updates on Rough Sleeper (Ricky) has been confirmed for Tuesday 24 May 2022 and 6pm. As you are all aware, Ricky was arrested on a number of charges including harassment. Cllr B Munro and myself spent a long day in court listening to the evidence, the final outcome was that he was given a 12 month Conditional Discharge, a victim surcharge and most importantly, served with a 2 year Criminal Behaviour Order. The Order Requires:

#### The defendant must not:

Live/sleep on public or private land/property (without the owner's permission) in the villages of Thorngumbald or Keyingham.

Urinate or defecate in the open air in a public place.

Remain in an area if ordered to leave by a Police Constable, Police Community Support Officer or owner of the land

I have since spoken with ERYC Sam Green and it is agreed that the public meeting should still go ahead so residents can be informed of the outcome and what they can do in the future.

- Jubilee Committee met again on Monday evening to put final details together, meeting to plan the field on Monday evening at 6pm. Members were asked to offer their help on the day to support the event.
- Lighting of Beacon Due to be lit on Thursday 2<sup>nd</sup> June at 9.45pm.
- I have received a good response for Commemorative Pin Badges and have allocated over 100 so far and another pile of applications on my desk.

- ERYC Traffic Management have declined to install additional Deer Signs entering the village on Thorn Road stating 'In accordance with guidelines issued by the Department for Transport (DfT), for any requests for 'Wild animals likely to be in road ahead' warning signs (diag 551) to be considered, we would need to be certain that the road referred to forms part of tracks regularly used by the deer rather than isolated incidents. Also, DfT are looking for us to de-clutter i.e. reduce the number of signs as much as possible as opposed to erecting more' (Street History report) back to 1/4/2019. Since then, there has been just one such report ('DEAD' enquiry no. 4022716 logged on 5/2/2020) and no 'OODA' (out of hours) reports.
- Emailed ERYC Terry Weaver Highways, asking him to chase up installing bollards on Marsh Lane, I also sent photos showing that cars parked on the verge making it difficult to pass.
- I have again emailed ERYC David Woodmansey for an update on the installation of the public footbridge from Camerton to Marsh Lane Ryehill, no reply received yet the last update was he was trying to get a site visit with the new occupier and site engineers.

#### 589. Receive Information:

- A thank you letter from H.A.R.T. confirming receipt of donation of £250.00. This is used to support the local community and is very much appreciated.
- ERYC confirmed that a grant of £500 from the Queen's Platinum Jubilee Community Fund had been granted. As agreed, this will be used to purchase a bench to sit alongside the Rowen Tree planted for the Queen's Green Canopy in the Cemetery.
- Email received from ERYC informing of footway improvement works taking place around the village. This was forwarded to members and added to the Website for information.
- Letter from Holderness Health informing that admin staff will be moving to a new building to enable them to deliver improved services to patients. Cllr Ferrier told members that at the last Forum only 2 councillors attended, him and 1 other which was disappointing. Cllr Richardson agreed to step in to represent this Parish alongside Cllr Ferrier.
- Members were informed that the next Yorkshire Energy Park Community Forum would be held on Thursday 16 June at Preston Community Hall.

#### 590. To Resolve:

- Clerk asked members if the June meeting could be moved forward 1 week to 29 June 2022 – RESOLVED
- ERYC confirmed that the 2 Councillor vacancies could be filled by co-option, 4
  applications were received, and following a vote, Antony Forrester and Mark Lundgren
  were co-opted as new councillors. Clerk to inform new councillors, also to inform the 2
  unsuccessful candidates.
- A quote for £900.00 was received to prune 2 Sycamore Trees on Amenity Area and prune overhanging branches and felling poor formed trees on playing field – RESOLVED
- Clerk told members that the Bank Mandate needs to be updated, Cllrs Munro, Melia-Craven and Kirlew-Morris to be added.
- A letter from Holderness Teacher Research Group which is a group of 9 Primary Schools in East Yorkshire including Thorngumbald Primary School, saying they had

been awarded a grant from the Royal Society of Chemistry to enable them to run a STEM day at Craven Park, Hull, they are asking if Parish Council could offer financial support towards transport to enable this to take place. Clerk spoke to the Group to ask how many children from Thorngumbald Primary would be involved and was told 60 children. After discussion, members agreed to contribute £600 towards the transport which equates to £10.00 per child - **RESOLVED**
