#### 601. Confirmation of Minutes:

Correction Minute 596.3 Shelly Bentley should read Shelly Hall. 597.1 Cllr Richards should read Cllr Richardson. The Minutes of the meeting held on 18 May 2022 were then **RESOLVED** as a correct record of the proceedings thereat. Cllrs Hardy, Munro, Steel and Twidal abstained due to not attending at the meeting.

#### 602. Clerk's Report:

- As previously minuted, the Holderness Health forum will go ahead on 16<sup>th</sup> August, Cllrs Ferrier and Richardson will attend.
- I have been notified by ERYC that a case officer has been allocated regarding the property
  with a very large amount of waste at front and rear which is causing problems for the
  neighbours, am awaiting update.
- Regarding Police and Crime Commissioner Grant Cllr Richardson has contacted local artist as requested, will put this on Agenda for next meeting due to her not been at meeting.
- I spoke to Wayne Bemrose at ERYC regarding litter bins and, as already explained, all
  purchases and installations must be made through ERYC via their recognised provider.
  Any location would first have to be agreed by one of their supervisors who would meet on
  site to discuss suitability. Criteria would include location, accessibility and footfall etc. Cllr
  Kirlew-Morris emailed some information yesterday but this was too late to be added to
  agenda, this can be added to Agenda for September meeting.
- Streetscape have acknowledgement the recent order placed with them and will be in touch once they have a confirmed date to carry out the works.
- AGAR has been submitted to PKF Littlejohn and the 'Exercise of Public Rights dates' are on the notice board and website.
- I have placed the order to purchase the Platinum Jubilee Bench and am waiting a delivery date.
- I am receiving regular emails regarding broken fence posts on the amenity area, these are replaced as quickly as possible. Work has started on replacing the old posts with concrete posts and new fence but this will take time.

 I am receiving a number of complaints regarding overgrown hedges, under the terms of the Wildlife Act, roadside hedge-cutting is only permitted between 1 September and the end of February.

#### 603. Receive Information:

- Cllr Ferrier asked again if any members would be willing to join the Community Speed Watch, a minimum of 6 people are needed to be accepted. Unfortunately not enough people have come forward, it was agreed to put this in the next Parish Journal.
- A Playing Field License/lease for Thorngumbald Barrons was discussed at length. Cllr Munro told members that it needs to be carefully worded to ensure that Parish Council are still owners. Clerk was asked to contact Thorngumbald Barrons to ask if they would still be able to apply for funding if they were giving a licence rather than a lease.
- Letter received from Thorngumbald Pre-School Clerk told members that she was
  Secretary to the Pre-school and had no input into the letter. She asked the Chair
  to read letter. Members discussed the content which was raising concerns that had
  caused some upset regarding a Councillor entering a scarecrow in the Scarecrow trail.
  This was discussed and members agreed Cllr Munro as Chairman would respond to
  letter.
- Members received an email regarding Fusion for Business (FFB Programme).
   Members agreed that this was not something they would be interested in but may look at it again in the future.
- Clerk asked members again for their input into the next Parish Journal, some ideas were Introduce new councillors, Community Speed Watch, Approaching Primary School/Holderness Academy for some input. Following discussion it was agreed that it be added to the September Agenda for further discussion.
