MINUTES OF THE PROCEEDINGS OF A MEETING HELD ON WEDNESDAY 19 OCTOBER 2022

616. **Apologies for absence:**

617. **Confirmation of Minutes:**

- The Minutes of the meeting held on 28 September 2022 were **RESOLVED** as a correct record of the proceedings thereat. Cllrs Richardson abstained due to not attending at the meeting.

618. **Clerk's Report:**

- I have had no response to my follow-up email to ERYC regarding the property with a very large amount of waste at front and rear which is causing problems for the neighbours, so I contacted Ward Cllr David Winter. He agreed to meet with me at a neighbouring property so he could see the problem. Cllr Winter contacted ERYC on our behalf and has been told that they are at the stage of trying to determine the best course of action to resolve this matter. They can simply prosecute, but that would not remove the waste. They can undertake works to remove the waste and prosecute and hope to recover our costs through a prosecution. This is not a certain outcome and there will be a high cost to clearing this property, which is a consideration from a budgetary point of view. ERYC Case officers were visiting the property this week and will report back to Cllr Winter their course of action.
- Date for diary – Local Election Thursday 4 May 2023.
- I contacted other clerks on our forum to discuss 'Fusion for Business' and of those who replied, there has been little uptake from town and Parish Councils.
- I contacted ERYC regarding the 40mph signs when entering the village from the bypass as these are very faint, this was raised during the Streetscene walkabout in May and is still on the to do list – I have asked that it be brought to the attention of the relevant department as a matter of urgency.
- A piece of equipment on the Amenity Area – Wooden Train – was removed because it was damaged and deemed dangerous. It was thought that it could be repaired but I think the damage is worse than originally thought. I have contacted Streetscape for a site visit to see about a replacement and get costs etc. It may be that we can apply to Lottery Funding – Awards for All - to pay for it.
- Bench on Main Road is now repaired, oiled and back in place.
- Bench at Cemetery is being installed next to Rowan Tree.

619. **Receive Information:**

- Kings Coronation will take place on Saturday 6 May 2023, members agreed it would be nice to celebrate this with something similar to what was done for the Queen's Platinum Jubilee. Cllr Hardy said she would ask the Jubilee Committee if they would be willing to help organise again. Cllrs I Bottomley, D Hardy, C Richardson, T Forrester and Clerk agreed to help.
- Members received a copy of the latest Humberside Police Newsletter, relevant parts of this will also be included in the Parish Journal.
- Members received a copy of ERYC's Cost of Living Support Measures as part of the Help for Households Campaign. This has also been put on the Website.
