#### 815. Confirmation of Minutes:

The minutes of meeting held on 21 May 2025 were **RESOLVED** as a correct record of the proceedings thereat. Cllr Kirlew-Morris abstained due to not attending the meeting.

## 816. Clerk's Report:

- Payment has been received for Allotments 22B and 23B
- I have received notification that the Post Office will re-open in Londis on 1 August 2025.
- Allotment competition took place on Sunday 15 June 2025, I will notify the winners the presentation will be held on 23 July 2025 at 6.30pm.
- I have contacted John E Wright regarding vinyl's in the bust stops, I have sent measurements and photos etc and they are going to put together costings which I can bring to the July meeting.
- There has been a report of another near miss with a pedestrian and bus on the Zebra crossing

   this was reported to EYMS who said they would investigate the matter they have since been in touch saying the CCTV footage was no longer available so could not take the matter further.
- A resident has some small oak, horse chestnut and sycamore saplings and is asking if the Parish Council have anywhere to plant them?
- Response from ERYC regarding tree on the Old Junior School Site that is overhanging the
  pavement I asked that it is looked at urgently. This has previously been reported.
   TREES714306064 The branch of the poplar, coming through the hedge by the
  Camerton Pub, someone had 'butchered' this and looks nothing like the picture sent,
  again our teams are there to remove the offending broken piece left by whomever."
- Following an accident on Station Road, the fence next to the old railway line has been damaged, I have reported this to ERYC asking for it to be replaced. Response from Countryside Access I will arrange for the fence to be repaired when I have a contractor available to do it. Could you request that the residents report all the illegal motorbike/quad bike use of the rail trail to the police as it is a matter for them. Ask them to request log numbers

I will get in touch with 'Parish Open Door' to discuss the above two items as I seem to be going round in circles and nothing is getting done.

ERYC have also responded to the overhanging tree on Beech Avenue and the amenity grass alongside of Willingham Garth – They have said they are not responsible for this and will no longer cut the grass and that it is the responsibility of the Parish Council – Cllr Gallant has also tried to seek clarification on this and we are waiting to hear back from them.

#### 817. Receive Information:

- Following discussion with Harry Mills of Andrew M Jackson Solicitors, the Conveyance and Trust Deed for Plumtree Road Playing Field has been located, however as previously advised, it states that the land is conveyed to Thorngumbald Parish Council as Custodian Trustees, which means that TPC have no power to grant a lease. To be able to register the land the solicitors will have to navigate the historic legislation of the current Trust Deed and translate to modern legislation. There is a lot of research that needs to be done to be able to register the land in the name of Thorngumbald Parish Council as sole legal and beneficial owner and the estimated cost is £3,000 £5,000 plus VAT, this could take a year to register. It was agreed to arrange to meet with Thorngumbald Barrons to update them on the situation and bring back to the July meeting to Resolve.
